* STARLINK SATELLITES ARE TURNING BLUE *

When SpaceX first started launching Starlink satellites in 2019, astronomers <u>saw red</u>. Now they're seeing blue. "Recently, a number of people have reported sightings of blue satellites," says Croatian astronomer Marko Posavec. "On the night of Aug. 11th, while observing the Perseids, I captured an entire series of them."

"It was Starlink group G9-1, launched in June," says Posavec. "These are DTC (Direct to Cell) satellites. Apparently, the material they're using to try to reduce brightness also gives them a blue color, for which SpaceX says is 'not unexpected.' The color is visible to the naked eye."

DTC satellites are SpaceX's attempt to create "a cell tower in space." The <u>first batch of six</u> was launched in Jan. 2024, and now there are <u>129</u> DTCs in orbit. According to <u>a recent study</u>, on average they shine nearly five times brighter in the sky than earlier Starlinks. The extra brightness is a probable result of their larger antennas and lower altitudes.

Earlier this year, SpaceX requested an amendment to their license with the U.S. Federal Communications Commission allowing them to operate <u>up to 7,500 DTCs</u> orbiting at heights near 350 km. If that plan comes to fruition, there might soon be many more blue streaks in the night sky

* FTC BANS FAKE ONLINE REVIEWS*

INFOPACKETS by John Lister

The Federal Trade Commission (FTC) has made it illegal to buy or sell fake reviews in return for payment. The new rule also outlaws lying about who wrote a review and includes several other measures designed to make reviews more trustworthy.

The "Trade Regulation Rule on the Use of Consumer Reviews and Testimonials" was approved unanimously by the FTC and, once formally published, will take effect after 60 days. It follows a consultation and review spanning nearly two years.

Threats Outlawed: The rule is wide-ranging, banning the following actions based on creating, buying or selling a fake review. This includes:

- *falsely claiming a review is by someone who doesn't exist (eg an AI-written review)
- *lies about the reviewer's actual experience, or claims to be from a reviewer who didn't actually use the product or service
- *paying a reviewer on the specific condition they express a particular sentiment, whether positive or negative*not revealing that a review is by a "company insider" such as an officer, manager, employee or agent
- *businesses claiming their site provides independent reviews when it covers rival products and services in its own industry this applies even if the business isn't reviewing its own products or services
- *using threats to make people remove or avoid writing a negative review
- *falsely claiming a review site is representative if reviews have been suppressed because they have a low rating or are negative.

The rule also includes a ban on buying or selling "fake indicators of social media influence". This includes cases where accounts are automated or hijacked to falsely inflate view counts or follower numbers. This ban only applies where the buyer knows the indicator is fake and uses it to make themselves look more influential or important or commercial purposes.

The FTC will have the authority to seek civil penalties of up to \$51,744 for each violation, with a court deciding what counted as an individual violation.

That's a standard penalty for breaching many FTC rules. The oddly specific amount is because it is increased by inflation each year.

VOA IS SHUTTERING ITS MARIANAS SHORTWAVE SITE

The Voice of America is shuttering its Robert E. Kamosa Transmitting Station in the Northern Mariana Islands.

The move was <u>reported by local media</u> in the U.S. Pacific territory based upon a letter from the United States Agency for Global Media.

"I suspect your organization has heard over the past week(s) about a big change taking place at the U.S. Agency for Global Media's Robert E. Kamosa Transmitting Station or REKTS. The change is a discontinuation of all shortwave radio transmissions at our Saipan and Tinian sites, the first step in closing the station," according to the letter.

REKTS consists of a transmitter and antenna system at Agingan Point at the southwestern point of Saipan and a second transmitter and antenna system on the western side of Tinian. The site is used for multi-language programming from Radio Free Asia and Voice of America into the East Asia region.

William Martin, director of the USAGM transmitting stations and operations division, stated: "By now many of you have heard that the "Voice of America" shortwave stations on Saipan and Tinian, which operated under the U.S. Agency for Global Media (USAGM), are closing. After decades of operation, these facilities are being phased out as shortwave audiences migrate to other media. Although these closures mark the end of an era, they are also bittersweet, as in closing these stations we also say farewell to the people and communities that supported our mission for so many years. On behalf of the agency, I would like to thank our staff and the many community members who contributed meaningfully to the stations' operation these many years."

Martin served as station manager for REKTS station manager from 2013 to 2019.

In recent years, USAGM has sought to redirect resources from shortwave broadcasting to other channels based upon where it can best reach its desired audiences. In its <u>2025 budget justification document</u>, the agency noted a full review of short- and medium-wave broadcasting requirements "leading to some reductions in regions where Agency research shows that shortwave audiences have become vanishingly small."

An additional challenge for REKTS was lingering damage from Category 5 Super Typhoon Yutu, which destroyed the station's infrastructure in October 2018.

According to USAGM's FY2023 Agency Financial Report, the storm shredded the 16 shortwave curtain antennas at the site and downed one of its support towers. Using salvaged parts, five antennas fully restored by the end of FY 2020, and three more were back in operation by end of FY 2023 with parts for three additional antennas on site.

According the report, the total assets held by USAGM in the Northern Mariana Islands had an approximate book value of \$5.4 million as of Sept. 30, 2023.

Previously, USAGM predicted it would have 11 of the 15 REKTS shortwave antennas fully operational by the end of FY2025. Additional capital improvements needed at the site included reroofing to prevent water leaks.

The site on Saipan first went on air in 1982 as Superrock KYOI, a commercial station targeting Japan with rock and pop music. It was acquired in 1986 by Herald Broadcasting Service. Radio Free Asia began leasing the transmitters in September 1996, purchasing the facility in 1999.

Construction of the Tinian site began in 1993 when the U.S. Department of Defense transferred 834 acres of land on the island to the U.S. Information Agency. The first transmissions from the site began in January 1999.
